

Knowledge College Question of the Day Contest

TERM: The Contest will run through October 30th, 2009 at 12:00 pm.

HOW TO PARTICIPATE IN THIS CONTEST:

1. (a) **Signing up for the contest.** To sign up for the contest you must register at www.knowledgecollegeinc.com/contest. You must agree ("opt-in") and accept our contest terms to receive Email regarding with weekly instructions on how to complete the contest.
